- There are two open public health inspector positions.
- Three Federal grants are on hold for the time being.
- Collin Graham provided the following updates for the Oklahoma Restaurant Association:
 - o Working with fire marshal on state legislation to extend the grandfather clause to existing mobile units.
 - o Safe harbor bill allows business licensee 3 critical violations within a 12-month period if attempts are made to correct violations.
 - O Wrote a bill to allow 18–20-year-olds with liquor license to open and serve beer and wine.
 - o Bill regarding interchange fees for credit card processing would be removed on taxes, tips, and charity contributions.
